AMENDMENTS

In the Punjab Police Welfare Fund Regulations – 2022, amended vide Notification No.1297/AD-Welfare, dated 03.02.2023:

In Rule – 23, under head **"Maintenance Allowance"**, the following amendments/additions have been made:

Amendment/Addition:

- "Maintenance Allowance shall also be given to the families of those Shuhada, during the lifetime of the widow, who are not entitled to pay after Shahadat to bring their pension at par with minimum wages set by the Govt. for a labourer."
- This shall be paid on quarterly basis w.e.f. 01.07.2023.

The above said amendment/additions in maintenance allowance policy may be circulated to your subordinate offices for compliance.

AMENDMENTS

In the Punjab Police Welfare Fund Regulations – 2022, amended vide Notification No.1297/AD-Welfare, dated 03.02.2023 and No.18242/AD-Welfare, dated 12.05.2023:

In Rule — 18, under head "Scholarship", the following amendments/additions have been made:

Amendment/Addition

- Those children of Shuhadas and Constabulary (HCs, PCs) who get admission abroad will also be given scholarships to continue their education.
- The maximum ceiling of scholarship fixed for private institutions at Home is also extended to the students getting education abroad.
- The above-mentioned amendment/addition shall be adhered to as per following policy guidelines/mechanism/criteria:

Policy of foreign scholarships for children of Shuhada & Constabulary

- Children of Shuhada and Police Constabulary studying abroad in foreign institutions will be awarded IGP Scholarship, one-time in educational career and maximum upto two years, depending upon duration of degree.
- These scholarships will be offered against an allocated amount for that particular year per policy.
- Students getting admissions abroad will apply for the scholarship on annual basis.
- Applications will be scrutinized and scholarships will be awarded on competitive basis.

Disciplines for Scholarships

The students studying in the following disciplines will be eligible:

- Medical & Dentistry field
- Engineering
- IT/Computer Sciences
- Business/Finance/Accounting/Economics/Environment Sciences/Public Administration & Policy.

Amount of Scholarships

- The scholarship will be awarded @ given to a student of LUMS/Agha Khan during a whole year.
- One-way ticket will also be given to the candidate winning the scholarship.
- Moreover, laptop/study aids will also be provided.

Criteria

- Applications for IGP's Foreign Scholarships will be invited online. An eligible students can apply by January 2024 for the scholarship.
- The Foreign university/institution must be credited/ranked by Q's or Time's ranking, dully recognized by HEC, for children of constabulary. In case of children of Shuhada the scrutiny committee will decide on case-to-case basis.
- Factors like international ranking of the university/institution, academic record of the students, significance of the academic discipline and financial support/scholarship already availed by the applicants will be considered by the committee.
- The committee after scrutinizing applicants against the parameter given before will recommend scholarships for the best candidates.

Composition of the Committee

Following will be the composition of the scrutiny committee for award of foreign scholarships:

- IGP/PPO (Chairman)
- Addl: IGP Finance & Welfare
- One Addl: IGP nominated by the IGP
- DIG Welfare & Finance (Convener)
- One Commandant of PTIs as Member
- One AIG as Member
- One Co-opted member from academia.
