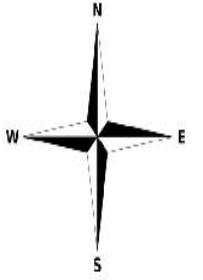
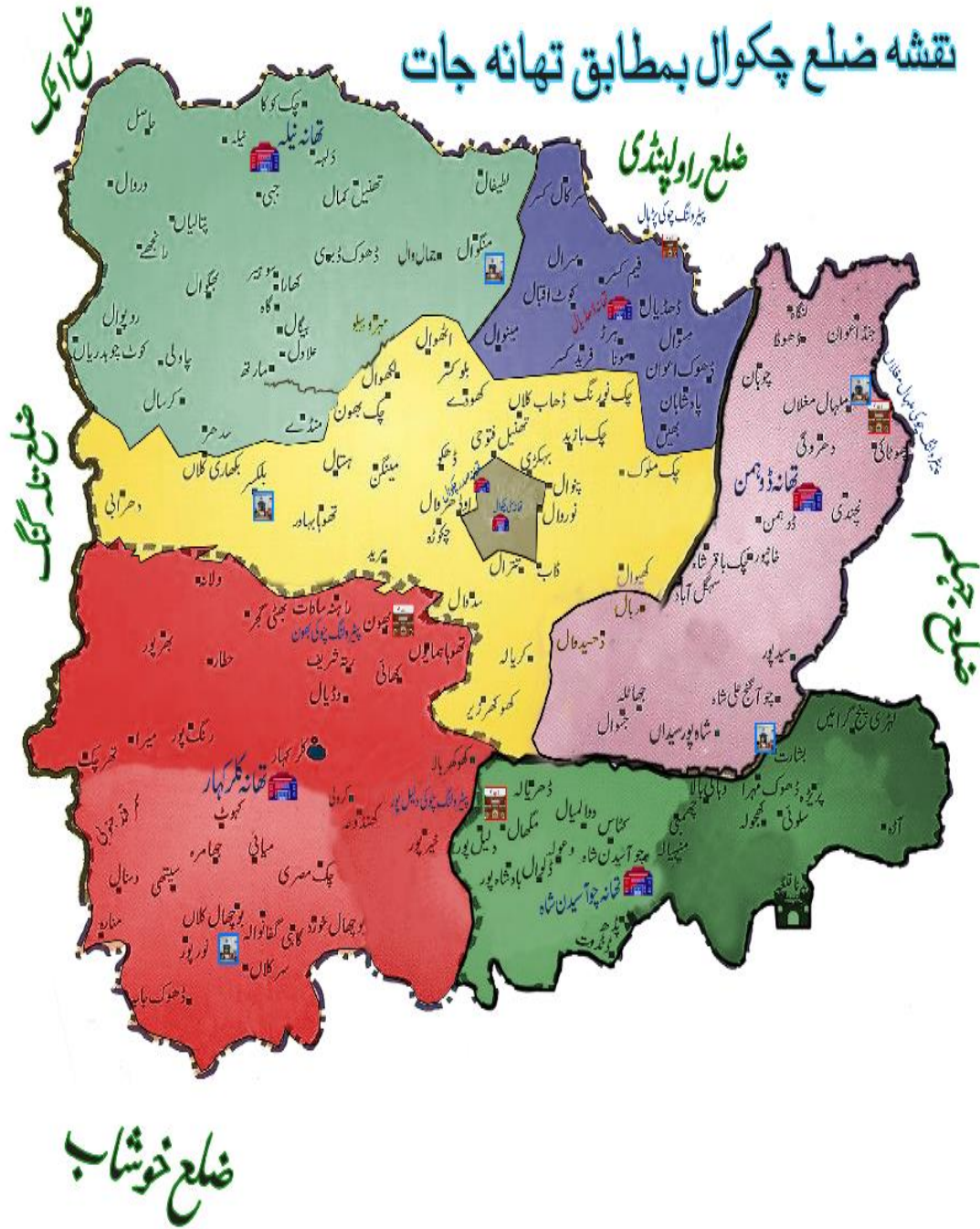

## FOREWORD

**P**lanning is looking to the future with eyes of present. Accurate planning is the foundation stone for achieving success in any field. The Police Order 2002, has made it mandatory for the head of the District police to prepare an annual policing plan and get it approved by the District Public Safety Commission.

**O**ur annual plan which is an important step towards describing our intentions for the future. Chakwal Police is charged with onerous responsibility of tackling dynamic and complex issues. The crime pattern in Chakwal is quite varied and includes problems like rising incidents of fatal accidents, car theft, cases of burglaries and hurts. Besides, provision of security to VVIP's, important installations and visiting dignitaries constitutes extremely important responsibility of Chakwal police.

**A**lthough Chakwal Police is coping with the task appreciably, there is still a long way to go for providing better service delivery to the people and controlling rising incidents of crime that creates general sense of insecurity in the minds of the residents. Crime in the field of narcotics has been remained increasing. Keeping the aforementioned picture in view the plan has given top priority to the following:-

- i. Reducing incidents of car and motor cycle theft
- ii. Curtailing the incidents of robbery
- iii. Controlling the number of fatal accidents
- iv. Making streets of Chakwal safer
- v. Improving confidence of public in police through better service delivery
- vi. Making Police responsive to the needs of the community.

## INTRODUCTION



In the prevalent scenario, policing has become a difficult task to foresee and over-awe the future development/happenings. The new dimensions of terrorism, suicide attacks on important personalities have made the issue, really challenging one and difficult. These difficulties and challenges when combined with the rising trend in crime rate due to deteriorated social economics and political conditions of the soil. Moreover increasing unemployment, meaningless education and other related environment require police to work in a more professional systematic and scientific manner.

The Police Order 2002 has introduced a lot of new changes in policing system of the country. In order to be more transparent, systematic and scientific in policing one of its requirements was the preparation of Annual Policing Plan for the District. This policing plan for District Chakwal is the result of our realistic approach with respect to ground realities and we have strived utmost to bring it in consonance with Police Order 2002 and proposed Police Rules 1934.

Chakwal is a different area of policing as it offers some of the challenges that are not essential components of the policing scenario elsewhere in the country. Chakwal police force is all set to deliver services to the people on the basis of analysis by revamping its orientation and attitude to confirm to the new good governance and motivated to undertake better service delivery through effective command structure and timely response to the public call and demands for assistance. The process of implementation and monitoring has been strengthened and sensitized for achieving the targets, objectives and goals contained in the Annual policing plan so that we meet the challenges of 21<sup>st</sup> century in a befitting manner. The issues of selection or recruitment of the best officers possible and the retention of this best lot have been addressed as well.

The annual policing plan 2023 is the result of wide consultation with the public and other relevant segments of society. Joint efforts have been made to make our first policing plan as the representative of our thinking tempered by genuine demands of the public and the guiding views of the public of District Chakwal. The objectives targets contained in this plan revolve around this important responsibility.

This plan primarily suggests of policing in District Chakwal for the calendar year 2024. Our important targets during the year under review, which we wish to achieve, financial and other resources which are likely to be available to Chakwal Police. This plan also gives a brief portrayal of our mechanism for achieving our specific targets. We have also taken into accounts the requirement of our resources that we must have to proceed ahead effectively, and have mentioned shortage of the same in this plan. The analysis of preceding three years is used as basis to set future policing targets and to ascertain the requirement of the resources. We have also given a pictorial importance of optimum distribution as well as optimum utilization of available resources in our policing plan.

In the year 2024, Chakwal Police will strive to improve service to the public and will continue to implement measures that contribute towards increasing the effectiveness of our organizations. We will maintain close liaison with the public to know what practices in their opinion best suit the purpose and mission of our service and how can we best serve them. This consultation will enable us to ensure that the police are continuously in touch with the needs, desires and aspirations of the public by explaining the rationale behind the policing priorities for the District Police who alone cannot have a long lasting effect on crime and disorder. We will work closely in partnership with the major stakeholders of the society, by the students, teachers, lawyers, lawmakers or industrialists. Our “Reach-out- policy alone can help us check the rising incidence of crime.

We plan to make Chakwal Crime free and create a sense of security, further to improve our working in crime against property. For these purposes our plan would show the optimum utilization of available resources.

Robbery, burglary, attempted murders and fatal accidents are being addressed and we hope that steps planned would show how a more responsive, service oriented and community connected police can deliver according to the targets set in the Annual Policing Plan.

The preparation of this policing plan was really a difficult and technical task, being a legal requirement as well. We have however with the blessings of Allah almighty prepared the policing plan under reference and pray to Him that he may make our efforts fruitful in achieving our planned targets.

## CHAKWAL DISTRICT A GENERAL PROFILE

Appreciation of scope and challenges of policing in a district requires, among other things, an understanding of certain peculiar characteristics of the district. Such features as geography, population, degree of urbanization, level of commercial and industrial activity, installations and places requiring fool proof security and relative importance of the district in the national context have a direct bearing on the nature of policing.

- Chakwal District established in 1985.
- The main Crops wheat, peanut, mustards.
- Strong sectarian history and sensitivity.
- Majority of inhabitants are lower middle class and are associated with army services as well as oversees Pakistanis as their source of income.
- District Chakwal has high level of political activism without any influence of political parties with major players.
- District Chakwal consists of 03 Sub-Divisions, i.e. Saadar Circle Chakwal, Choa Saidan Shah Circle and Talagang Circle. There are 11 Police Stations and 7 Police Posts.

According to the District Gazetteer Jhelum 1904, the city Chakwal is named after Chaudhry Chaku Khan, from Jammu who founded it in 1525 during the era of the Mughal emperor, Zaheerudin Babur. It remained a small but central town of Taluka Dhan Chaurasi for many centuries. In 1881, during the British era, it was declared the Tehsil Headquarter. It was finally upgraded to district status in 1985.

Chakwal is situated in Dhani region of potohar in northern Punjab. Chakwal and surrounding areas are home to ancient Soan civilization and it has a very rich history. The history of the area dates back to the semi-mythical period of the Maha-Bharat. Chakwal is a site of famous encounter of Alexander the great with Raja Ambhi. Chakwal region's district capital is the city of Chakwal. Chakwal District has five Tehsils i.e., Kallar Kahar, Choa Saidan Shah, Chakwal, Talagang

and Lawa. For many early years, this region was under the reign of Dogra Rajputs and Khokhar Rajputs.

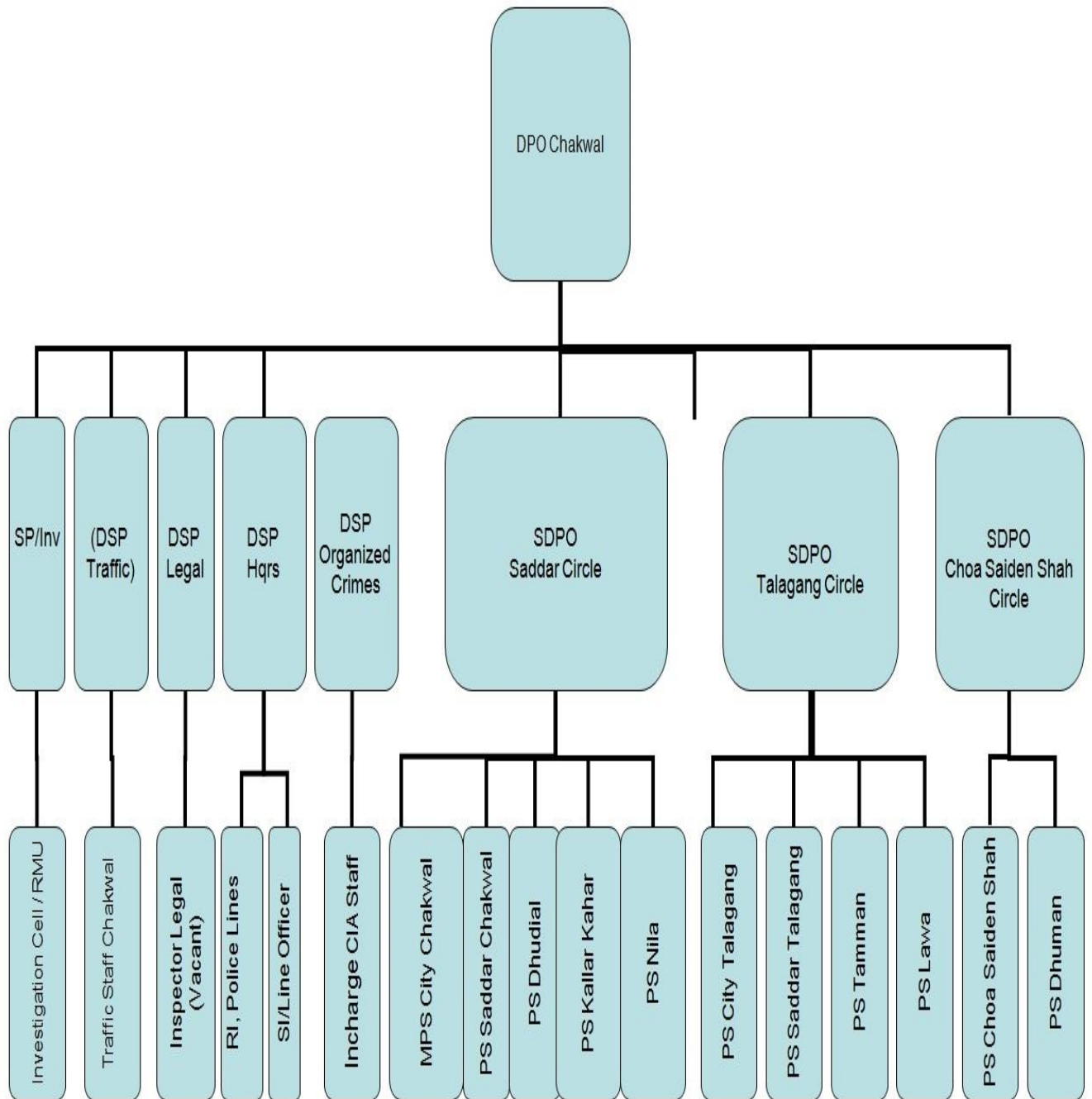
Chakwal city in itself, although heavily influenced by the village lifestyle, has more of an urban environment. Chakwal is also known as Military valley. Chakwal's unique culture and its rich history makes it a very interesting region. Chakwal has been bestowed by rich culture, history, art and extravagant environment. Once been known as a picnic spot of the Mughal Dynasty and the British Lords, Chakwal still offers a unique landscape to its visitors. World-renowned Kallar Kahar Lake, Takht-e-Babri, a stage built of stone by Emperor Babar to address his Army, Bagh-e-Safa and above all Katas Raj Temples (famous temples-fort and Medieval University surrounded by 100 temples built over a period of 1000 years by the Hindu rajas) are some ideal places for tourists. The famous temple of 'Katas' holds great significance for Hindus who come here for worship as Kitas's name is mentioned in Hindu holy book 'Maha Bharat' (written in 300 BC).

Chakwal was a non-industrial district, however several industries (Cement Factories and Spinning Mills etc) have been established. The other source of income of the people is agriculture. Holdings are not large therefore the financial condition of the general public is not solid. The youth segment of society is reluctant to follow farming as a profession. Since they do not find any alternative source of income, they engaged in criminal activities, such as theft, robbery, dacoity, motor vehicle snatching etc. Economic disparity breeds crime against property.

## **District Objectives of Policing**

### **i. Protect Life and liberty of citizen**

Our objectives are to fight against the crime and win by providing dynamic and effective law enforcement. The Chakwal Police will strive to uphold core values like integrity, courage, loyalty and fairness in order to promote professionalism and trust. Additionally, we will not be mere protectors of public, we should be guardians of the people and friends to the community and must be a service of tenacious individuals, bounded by a common purpose to serve and go beyond the call of duty. Our motto is based on the principle of 4Ps which says that policing can effectively be measured by purposeful, performance oriented, public centric and punitive action. Transformation of the District Police Chakwal into a service oriented, thoroughly professional, transparent and accountable to general public. .

### **ii. Preserve and promote public peace**

With the increase of complexity in the social fabric of Chakwal, maintenance of public order has emerged as a major challenge for police at district level. This year, it is resolved that the issue of maintenance of public order will be dealt with in a scientific and proactive manner. Extensive community – police interaction will be made to keep communities peaceful and law abiding. Interest groups should be identified and marginalized through proactive negotiations. Following guidelines are mandatory to follow;

- Maintenance of public peace and order during public protests, power riots, religious riots etc.
- Regulate processions and public gathering in accordance with Police Order 2002, Criminal procedure Code and Police Rules
- Maintain peace and harmony during Muharram
- Maintenance of peace on national days special occasions
- Work in unison with notables of the area and various pressure groups like Traders and Ulema for maintaining peace and order in accordance with government policy
- Activation of Peace Committees at Police Station level to develop interfaith harmony between the people of different sect
- Metal Detectors – Security measures adopted to guard sensitive Masajid / Imam Bragahs.
- Entry to all special events through Walk Through Gates
- Implementation of SOPs

### **iii. To improve police efficiency.**

Police in Pakistan is undergoing a major credibility crisis. Police should change its behavior and attitude towards the public in order to improve its public image. The world is moving towards the concept of Community Policing at rapid pace; which is policing strategy and philosophy based on the notion that community interaction and support can help control crime and reduce fear of crime.

- Open Kuchehries are being held regularly at DPO / SDPO office level to attend public complain and address their grievances.

## **FOOL PROOF SECURITY ARRANGEMENTS AT RELIGIOUS GATHERINGS/ PUBLIC MEETINGS.**

**In order to ensure law & order and protection of participant's at all religious/ public gathering following methodology would be adopted:**

- Comprehensive contingency plan would be prepared for law & Order situations arising out of Sectarianism/ inter-faith issues/blasphemy or any other issue having religious connotation.
- In order to associate different opinion leaders, meetings with religious leaders/ Ulamas/ Mashaikh/ Profession/ Business/ person's integrity etc would be regularly held. The peace Committees would be constituted representing people having good judgment who command respect and have effective following in their communities.
- Seminars/ Conferences on religious harmony at local level would also be arranged to bring communities in harmony.
- Meeting of inter-faith Harmony Committees would be held regularly to bridge the gap between different religious Communities.
- Monthly Meetings to review Law & Order situations would be held without fail.
- The activities of Khatib, fanning, hatred would be effectively checked and discussed during Monthly law & Order meetings.
- Prompt action would be initiated in cases of miss-use of loudspeaker and reviewed during monthly Law & Order Meetings.
- Action against the distribution of hate-literature, and appearing of wall-chalking against different sects would be reviewed regularly.
- The venue of religious public gathering would be protected by deploying uniformed/plane clothed armed Police personnel.
- The management of religious gatherings would be asked to deploy their volunteers at the entry-points of venue in order to check the suspicious elements.
- Metal Detectors would be invariably utilized.
- The management of religious gatherings would be asked to restrict the entry/exit points. So that the checking process could easily be performed.
- The management of gathering would be asked to bound down the guest/ Scholars to avoid indulgence in sectarianism.
