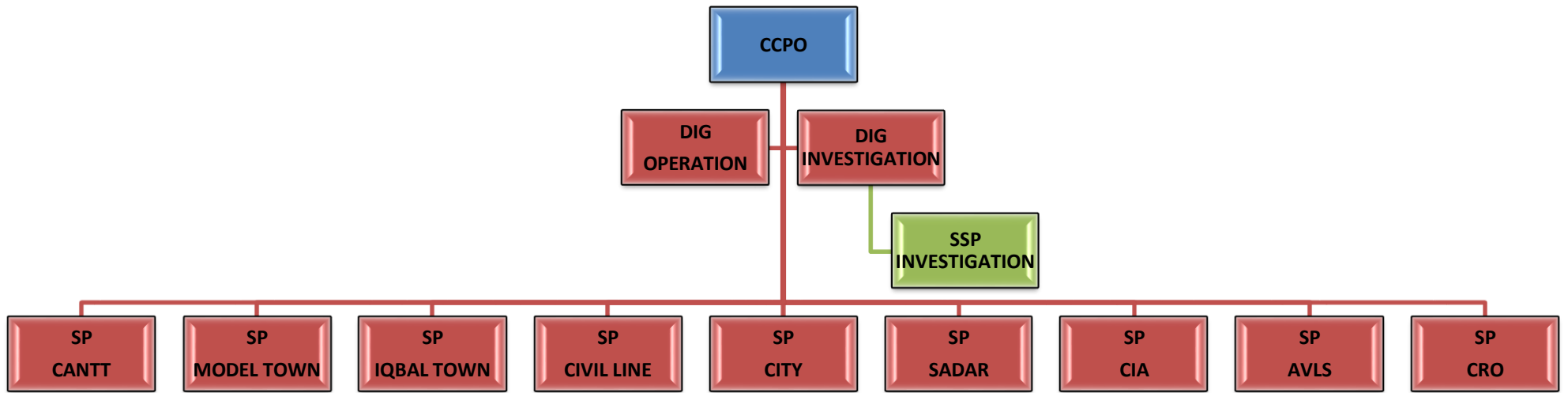

A BRIEF INTRODUCTION OF PLAN **(One paragraph)**

Lahore is financial and political hub of province of the Punjab. Being the metropolitan, people of different areas move to Lahore to earn their livelihood. Hence, the population of Lahore is increasing day by day. Resultantly, massive population leads to increase the chances if crime.

The crime rate of Capital City has been increased during last few years. Consequently, to curb the crime, new strategies and planning are being introduced time to time. Article "32" of police Order 2002 made the provision of the annual policing plan mandatory for every head of the District Police, in which he put forward detail of objectives and achievement and set targets to be achieved for good performance of the police.

Investigation Wing, a specialized unit has been established under Police Order 2002, to investigation the registered cases under the General Law, it mainly deals with the Detection of Crime through investigation.

OBJECTIVE OF POLICING

- Computerization of CRO branch was started in Lahore in 2002.
- The Current up gradation of CRO branch Lahore was done in 2016 which includes establishment of various branches to carry out investigation tasks in specialized and professional manner.
- All the branches are headed by SP CRO.

NEW INITIATIVES:

- Victim support center has been established at Investigation Headquarters to support the victim in better and modern way.
- New android mobile phones have been provided to crime mapping operators for smooth functioning of crime mapping software.
- CCTV camera has been installed in communication room for surveillance of CDR operators and their working.
- Family Tree facility has been obtained from NADRA.
- Bio Verisys facility has been approved by competent authority of NADRA. It will be installed in near future.
- Strength of PSRMS operators has been increased from 198 to 330.
- New locators have been approved by the competent authority for Lahore Police.

INVESTIGATION

- Under Investigation cases are on the higher side which needs to be reduced to maximum extent. Cases registered in 2017 to 2023 are which were still under investigation are being finalized.
- Case properties have not been sent timely to malkhanas concerned which are being reduced.
- Cases under arms ordinance have been found pending due to lethargic attitude and timely submission of challans will reduce pendency.
- Prompt Medical Examination in sodomy & rape/gang rape cases.
- CNIC of all accused must be feeded correctly in POLCOM.
- Cases in which the accused have been sent to the judicial lockups, the challans are not being updated in POLCOM within 14 days.
- I.Os & Incharges Investigation are advised to ensure that all objects raised by the persecution branch must be removed timely and submitted back.
- Maintenance of police stations record both manually and computerized (A number of cases in which IOs are not entered in POLCOM.
- Incharges / IOs are being allotted specific targets on daily basis for maximum arrest of nominated accused involved in large number of cases.
- Large number of newly added POs & Listed POs of category A & B, TOs & CAs which are at large , will be arrested by apply modern techniques.
- Incharges are directed to ensure that duty officer must call PSFA Labs & district crime scene unit at place of occurrence.
- Crime scenes of all heinous cases must be visited by the divisional SsP, SDPOs and Incharges.
- It has been noticed that in cases of narcotics, the complainants (Officers of Operation wing) are used to be reluctant to hand over the case property to the I.Os .
- Sample of case Properties must be sent timely to PFSA or other agencies.
- Any addition/Deletion of offence / offences, I.Os must update the same in POLCOM timely .
- Moharrers are responsible for entries in register No.4 and POLCOM.
- Entries in register No.19 must be made timely, delayed shows that the I.Os genuinely not recovered anything from the custody alleged accused. Case property must be handed over to quarter concerned timely.
- Challans must be submitted within prescribed period i.e 14 days after registration the case, if there is some impediments, then interim report should be placed before the court of competent jurisdiction.
- Zero tolerance in death and escape form police custody.
- The main case of pendency is that the I.Os on their transfer from one place to another, or not handing over the case files to the concerned/Moharrar/Incharge Investigation.
- If any superior court call any senior officer, the I.Os and Incharges are responsible to inform the concerned officer timely.
- A large number of complaints on very petty issues are pouring divisional offices, the divisional SsP investigation must devise mechanism to redress the grievance of general public.
- Qualitative investigation would nest prevention.
- Media projection should be made by highlighting the achievements in working out the high profile cases.
- In case of hardships the transfer/posting of any junior ranks would exempted form any policy.
- Demands of strength of investigation wing may be rationalized.
