MEMORANDUM OF UNDERSTANDING BETWEEN PUNJAB POLICE, LAHORE (PP) AND



MUKHTARAN RAFIQ FOUNDATION (MRF)

This Memorandum of Understanding is made on 16th of September, 2023 between Punjab Police, Lahore (PP) which is a Provisional Govt. Department of the country having its office at Bank Road, Old Anarkali, Lahore, hereinafter called the PP.

And

Mukhtaran Rafiq Foundation (MRF) which is an independent, Non-Political, Non-Profit, and Non-governmental social welfare voluntary Organization, having its hospital at canal bank scheme, Fatehghar, registered from Punjab Healthcare Commission, FBR and Pakistan Charity Commission that is helping the less fortunate which all deserve and needy ailing community of area, hereinafter called MRF.

Punjab Police, Lahore (PP) (hereafter known as first party) and Mukhtaran Rafiq Foundation (MRF) (hereafter knows as second party) shall hereinafter be collectively referred to as "Parties". Now it is Mutually Agreed by and Between the Parties as Follows:

- MRF will provide 100% free treatment to the dependent family members of PP SHUHADA's.
- MRF will provide 100% free treatment to the dependent family members of PP Ghazis (with disability or loss of any body part).
- MRF will provide free emergency and OPD services to the PP employees & their dependent family members.
- 4. MRF will provide 30% discount on the entire healthcare services (provided in MRWH) to the Staff and their family members of the first party upon presenting their PP valid Employee ID Card /refer letter.
 - (as MRF is a welfare organization, it is already providing all of its services at very cheap rates, but the above said persons will get further discounts on that rates, which will be very economical for patients)
- MRF will provide 50% discount on the diagnostic services (Laboratories) to the valid members of the first party upon presenting their PP valid Employee ID Card
