INTRODUCTION OF DISTRICT PAKPATTAN:

Pakpattan came into existence much before the invasion of the Alexander the Great, Sultan Mehmood Ghaznavi and Amir Taimur. The famous traveler/explorer Ibn-e-Batuta crossed the river Satluj at the point where presently Pakpattan is situated. Since the river used to flow closer to the town, called at that time Ajudhan, Akbar-e-Azam gave it the name of Pakpattan, due to the sanctity of Shrine of the famous mystic saint Hazrat Baba Farid-ud-Din Masood Ganj Shakar (R.A). Pakpattan was elevated to the status of district in year 1990, when it was carved out from district Sahiwal. Initially, it comprised of one Sub-Division but in January 1995, Sub-Division Arifwala was also made a part of this district. The district headquarters Pakpattan is situated on the main road, connecting Multan with Pakpattan. Length of the Multan Pakpattan road (old Dehli road) within the district is 66-Km, from Bunga Hayat in the East to Rasool Pur in the West. Other main traffic route is Sahiwal to Bahawalnagar via Arifwala. There is also one main canal namely Pakpattan Canal which passes through both of the Sub-Divisions, which length, within the district, 45.33 km. The district also falls on Railways track, from Pakpattan to Lodhran. The length of Railways tract, within the district is 47.85 km. Main towns of the district are Noor Pur, bunga Hayat, Malka Hans, Qabula, Ahmad Yar and Muhammad Nagar. So far as, Geographical location of the district is concerned, it lies at an approximate height of 160 meters from the Sea level and is bounded by the river Satluj in the South, district Okara in the East, district Sahiwal in the North and district Vehari in the West. Area of the district is 6,74,212 Acres while its population is 1823687, according to the census of 2017.

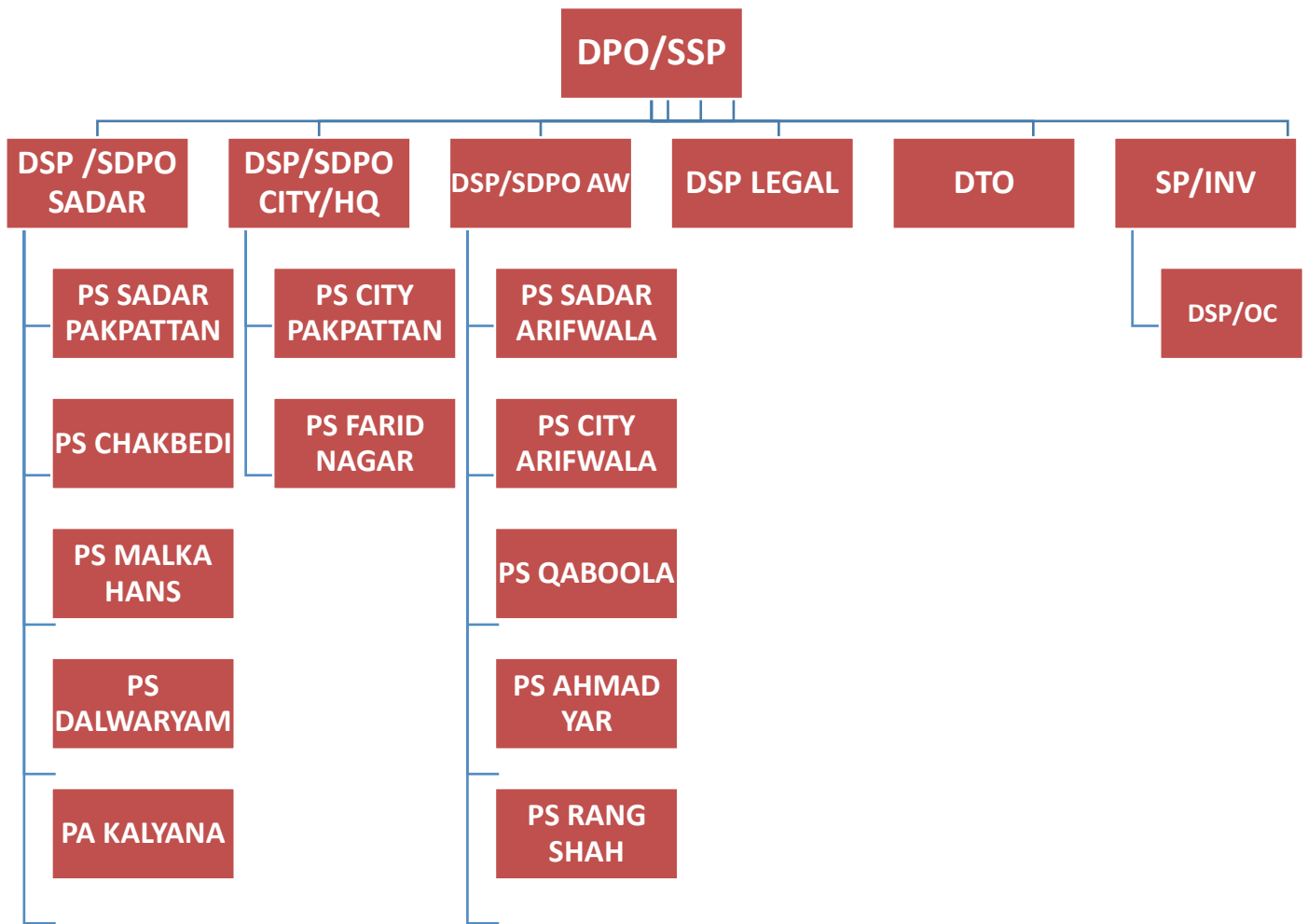

- Promote Police-Public Partnership through community policing.
- Crime Prevention efforts to reduce polarization that exists between police and citizens.
- Constitution of Peace Committee
- Open Door Policy for the complainants.
- Stakeholder Management can reduce the crimes in the society.
- Market Committees formulation in the cities resolve the matter of the concerned business people in their areas of jurisdiction.
- Students, Internships and volunteers help about reporting of crimes can help in arresting the crimes in the locality.
- Thikri Pehra can play role to stop crimes against property and persons.
- Awareness Walks/Seminars can educate the people about the crimes and utilization of prevention techniques in the communities.
