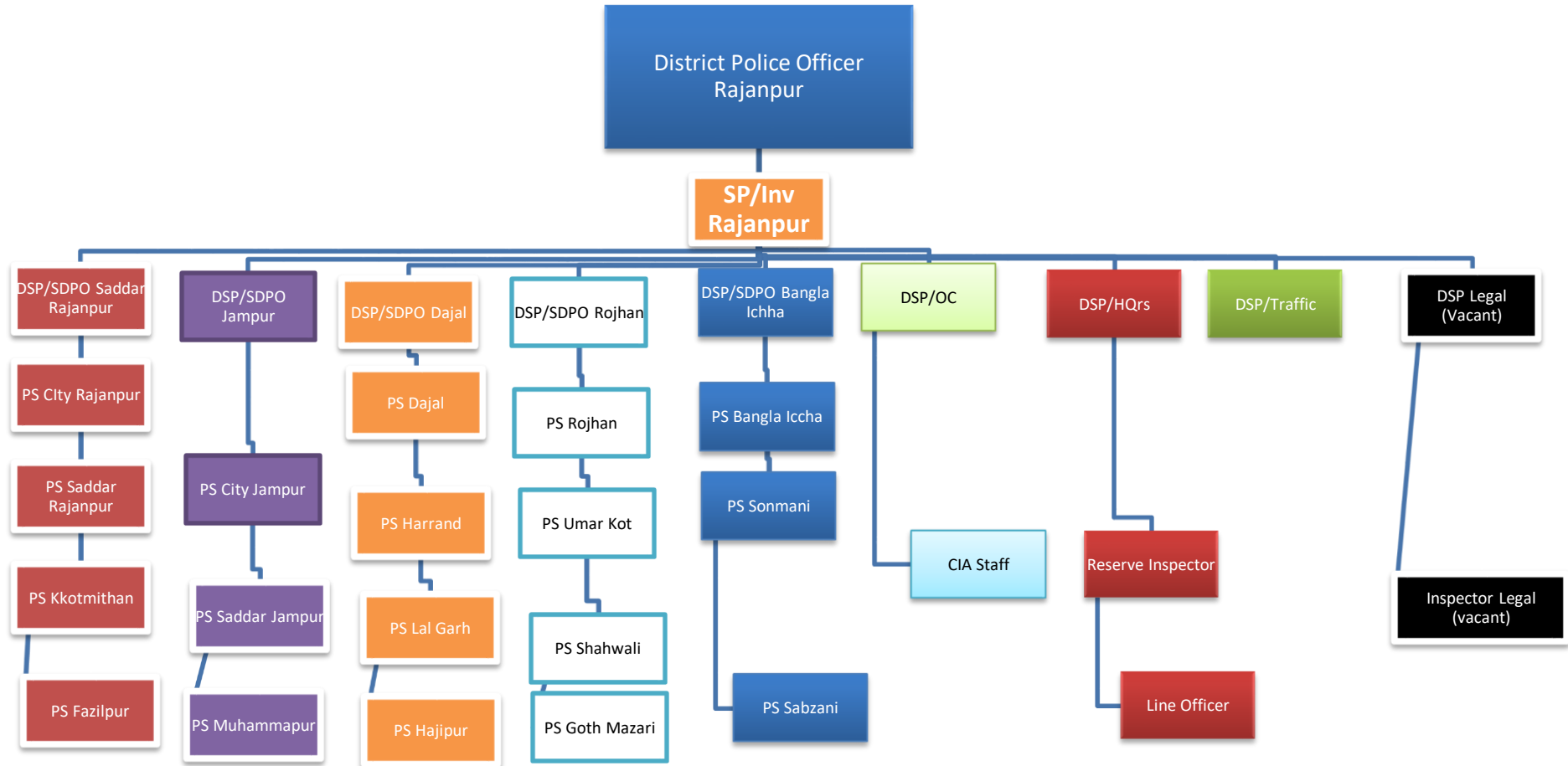

## **(1) Introduction**

---

Article 32(4) of police order 2002 enunciates that head of District police shall prepare an annual plan in which details regarding objectives of District Police, Availability and utilization of financial and material resources during the year, targets as well as mechanism to achieve the targets are to be mentioned in the plan. District Annual report plays a pivotal role in decision making, management of men and material, policy formulation and other activities carried out by District police in pursuance of its objective i.e, protect lives and properties of its citizens. As it is truly said by veteran American author and radio speaker Earl Nightingale that *“All you need is the plan, the road map, and the courage to press on your destination”*, similarly roadmap is very necessary to set the targets and to get those targets accomplished with collaborative efforts. In compliance with the statutory requirement, the Annual District Plan 2022-23 is articulated after thorough deliberation and keeping in view the forthcoming requirements of the district police. The prime and utmost objective of Rajanpur Police is to provide not only protection but sense of protection to citizens by adopting proactive policing approach. Arresting the perpetrators and Proclaimed offenders in furtherance to get them scrutinized by investigation process of police and send them to courts of law along with collected evidence so that such persons may be convicted by courts of law and society may be protected from such ill minded criminals. It is always required by the governments and the civil society that police culture at police station level should be changed and it should be people friendly and polite. Strategies to make police, as a public friendly organization are also included in the priority list of this District. For accomplishment of desired goal, resources are inevitably required. ## **b. Population**

According to the census 2017, the total population of the district is 1.995 million. While according to census 1998, the total population of the District was 1.100 million which grew with the growth rate of 3.16%. The major portion of the population is living in the rural areas. The proportion of rural and urban population is 83.1% and 18.9% respectively<sup>2</sup>.

## **c. Area of the District**

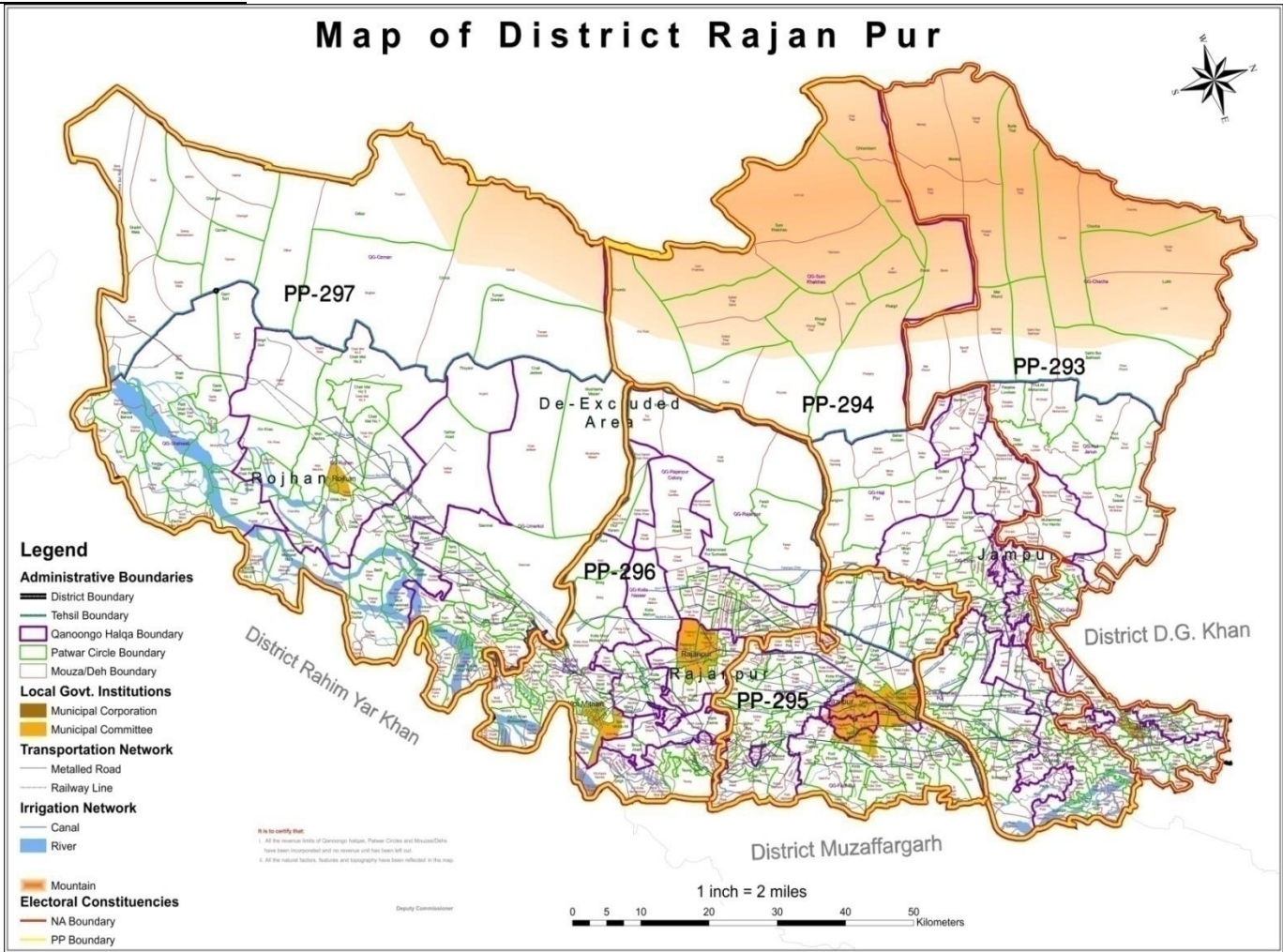
Rajanpur is one of the peaceful districts in South Punjab which is located at 31° 9' 35" North, 73° 22' 55" East longitude. This district is situated in the west side of River Indus. Its north side is bounded by Dera Ghazi Khan **District**, and west by Dera Bugti **district** of Baluchistan province. The east side is bounded by Muzaffargarh and Rahim Yar Khan **Districts**, while its south part is covered by Kashmore **district** of Sindh province. The map of the District is also given below.

Rajanpur covers the area of 12,318 square kilometers. The area covered by District Rajanpur is approximately 5% of total area of Punjab while 1% of total area of Pakistan. Areas covered by Tehsils of the district is given in the table below,

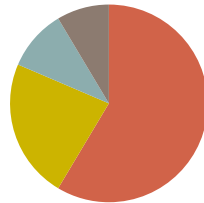

- Assist other government agencies/departments in discharging their functions/duties

## **2. Targets to be achieved**

- Maintenance of law and order.
- Physically apprehensions of absconding accused persons and POs, CAs etc.
- Campaign against militancy and radicalization
- Countering terrorism and averting the chance of any subversive activity by miscreants.
- Security of Key Installations and Foreigners.
- Free registration of cases.
- Transparent and speedy Investigation of criminal cases.
- Prevention of heinous Crimes by adopting proactive approach
- Providing foolproof security to the religious, traditional and political events like Muharum, Bisakhi, local bodies' elections etc which are likely to schedule in coming year
- Management of traffic and making arrangements to minimize the chances of traffic accidents
- Preparation and implementation of effective Patrolling plan.
- Now a days, on the Directions/Instructions of Government of Punjab, a grand katcha operation is continue against the katcha criminals/ gangs under the supervision of DPO Rajanpur in Circle Rojhan to maintain the law and order situation in the area.

### **3. Administrative targets**

- Improvement of Police Image by changing police culture at Police station level.
- Developing mechanism for Community Policing.
- Redressal of Public grievances.
- Implementing and improving system of Monitoring & Vigilance.
- Improving Discipline of police force and ensure Accountability.
- Improving capacity of police officers by professional courses
- Merit Based Recruitment of police personnel.
- Welfare of the Force.
- Improving public awareness regarding police Service Counters.
- Up gradation of I.T section, C.R.O branch.
- Proper and transparent utilization of financial resources

### **4. Mechanism for achieving targets**

The strategy to achieve the above mentioned targets may be abridged as,

#### **(i) Maintenance of Public order**

District Police will maintain law and order at any cost. For this purpose, discreet information regarding activities of the groups who may threat to law and order will be collected through District Security Branch and other sister intelligence agencies. The matters related to law and orders are also discussed in the meetings of District Intelligence committee. On the recommendation of DIC, miscreants are detained, gagged or monitored.

In case, the situation is going to be volatile, police contingent is deployed to secure lives and properties of the general public.

**(ii) Drive against militancy**

Following procedure will be adopted to check militancy in the district.

National Action Plan will be implemented in letter and spirit. Surveillance will be conducted for the Madaris engaged in fanning sectarianism in the vicinity. Effective control on chanda collection by proscribed organizations. Strict action against publishing, printing and dissemination of hate material. Strict action on misuse of loud speakers. Monitoring of activities of persons on 4<sup>th</sup> schedule, ATBs, RAPs, LMEs etc. Banning of public meetings by proscribed organizations. Frequent meeting by District Peace Committee and close liaison with sister intelligence agencies i.e. Special Branch, CTD etc.

**(iii) Combating Terrorism**

Comprehensive security plan of the district as well as evacuation plan has been prepared. Optimum efforts are being carried out to avert any possibility of terrorism. For this purpose likely targets of terrorists have been secured at possible level. Security of buildings under threat particularly, police buildings like District Police Office Complex, Police Lines, Police stations and Police Posts, Government Buildings like DCO Office Complex, Judicial complexes at District & Tehsil level, District Jail, etc has been tightened. Security of Educational Institutions has also been ensured. Security of Mosques and Imambargahs, Processions and religious congregations with special reference to the security of places of worship of minorities i.e Qadyanies and Hindus have also been covered in the security plans of the district. Fool proof security shall be given to VVIPs; VIPs visiting Rajanpur as well as foreigners visiting this district shall be provided foolproof security.



**(iv) Free Registration of FIRs**

Free registration of case is the right of every citizen who has been subjected to any illegal action. To ensure free registration of the case, following policy will be adopted.

Each and every case will be registered by the SHO on receipt of information of cognizable Offence. Any laxity by the local police in registration of case will be taken seriously. DSPs/SDPOs will monitor free registration of case in their areas of jurisdiction. All Gazetted Officers will conduct field tours and conduct open courts in remote areas to ensure that public grievances are being redressed properly.

**(v) Transparent and quick investigation of the criminal cases**

Fair investigation will be ensured in all heinous crime so that justice could be provided to aggrieved parties. It will be ensured that every case is investigated purely on merits, reports u/s 173 Cr.P.C will be submitted in the courts of law within stipulated time period as envisaged in the procedure. The local Police will be responsible to ensure free and fair investigation of the cases under the direct supervision of the SDPOs. SP/Investigation will be overall Incharge of the Investigation Branch and will monitor each and every case and the performance of the Investigation Officers.

The Investigating Officers if found guilty of faulty investigation, will be dealt with severely. Delay in submission of challan to the court of law will be taken seriously and delinquent officer will be taken to task.

(vi) **Prevention of crime**

Special emphasis would be given to provide safety and security to the commuters on the highways to avoid any incident of highway dacoity / robbery. In this regard instructions are also given to Punjab Highway and patrolling police. Special focus would also be given to riverine belt of Indus River to avoid any infiltration of criminals or miscreants. The area would be intensified by Police presence through riverine police posts to avert any criminal activity.

The Punjab Security of Vulnerable Establishment Ordinance, 2015 will be implemented in letter & spirit. To avoid the incident of robbery / dacoity against financial institution like bank, jewelry shops, money exchangers, Prize Bonds Dealers, Shopping Plaza and Petrol Pumps, strict action will be taken against the defaulters to compel them to take necessary precautionary measures as indicated in the Ordinance.

Frequent hold ups will be conducted to check the movement of the criminals with particular reference to the vehicle having fake number plates or without registration.

The members of Masalehati Committee and Peace Committee would be utilized to resolve the conflict among the society particular the known enmity to avoid the incident of Murder, Attempt to Murder and Hurt.

A campaign will be launched against the P.Os particularly of heinous offence like murder, kidnapping for ransom, dacoity / robbery for their arrest and proceedings u/s 88 Cr.P.C. will be initiated.

## **Mechanism to achieve administrative targets**

To achieve the administrative targets, the following steps will be taken in pursuance of accomplishment of the targets

### **(i) Improvement of Police image**

Zero tolerance policy will be adopted towards Police torture, illegal confinement, use of filthy language and corruption. Involvement of community shall be ensured by introducing the concept of community policing in the shape of “Masalehati Committee” and Peace Committees at district, circle and Thana levels. Proper Check shall be maintained on false registration of cases. Proper heed will be given for Redressal of public complaints. Productive interaction will be developed with media. Stern disciplinary action will be taken on complaints of misbehaves with public, moral and financial corruption.

### **(ii) Improvement of Front Desk Performance**

Front Desks are established at all Police Stations of this district. Special focus is given to improve the performance of front desk officers. In this regard, response within 24 hours period on complaints is being sent to the office of W/IGP through front desks.

### **(iii) Redressal of Public grievances**

Separate complaint cell is established in the office of District Police Rajanpur for prompt disposal of complaints. Special emphasis is given on complaints against Police officers regarding torture, misbehave, moral and financial corruption. Open courts will also be held by DPO/SDPOs/SHOs for redressal of public complaints.

**(iv) Inspections of the police stations**

Surprise inspection of the Police station shall be carried out by Senior Police Officers. Besides this formal and informal inspections of the Police station and Sub Divisional Police Offices will be completed in order to maintain and update the record of the police stations.

**(v) Up gradation of IT section and CRO**

It is a target of District Police to upgrade I.T section and CRO to get best results. A website of District Police has been launched which will also be updated according to demands of a successful organization. Record of finger prints and modus operandi of the criminals will also be updated in CRO. Record of photographs of criminals is being also maintained and shall be updated properly.

**(vi) Computerization of offices & Police stations and provision of different services to the general public**

All the Police station record is being computerized on priority basis. Moreover, police control and command center has been established in DPO Office Rajanpur, in which 15 desks have been established related to different tasks i.e, IT, CDU, HRMIS, Rescue 15 etc.

**a). Police Khidmat Markaz**

Police Khidmat Marakiz have been established at District Headquarters as well as at Tehsil Headquarters Jampur. In these Marakiz, 14 services are provided to the citizens at their door step. These services include 1. Police Character Certificate, 2. General Police Verification, 3. Vehicle Verification, 4. Mobile Phone verification service, 5. Loss Report, 6. Report regarding missing children, 7. Crime Report, 8. Legal Aid for Women, 9. Copy of FIR, 10. Entry of tenants, 11. Employee Registration, 12. Learner/ driving license, 13. Renewal of driving license, 14. International Driving License.

**b). Police Khidmat Counters**

Police Khidmat Counters have been established at DHQ Hospital Rajanpur as well as at THQs Hospitals Jampur & Rojhan. At these counters, 07 services are provided to the needy persons i.e, 1. Medical Certificate, 2. Copy of FIR, 3. Tenants Registration, 4. Crime Report, 5. Loss Report, 6. Legal Aid/ Women violence, 7. Employee Registration

**c). Police Tahafuz Markaz**

Police Tahafuz Markaz has been established at district Headquarters Rajanpur to provide help to the vulnerable section of the society i.e, Transgenders, Disabled persons, under age addicts, Special persons, Homeless children, Children/ Women who are victims of sexual violence, Child Labor etc.

**d). Establishment of MEESAQ**

**(Minority Rights & Interfaith Harmony Unit Punjab Police)**

MEESAQ has been established in DPO Office, Rajanpur to provide following services to the minorities.

- i. All policing services (PKM) ii. Interfaith harmony awareness and meetings.
- iii. General grievance resolution. iv. Ensuring implementation of national narrative.

**(vii) Welfare of the force**

MOUs have been signed between Police and Private school associations for Fixation of separate quota for children of police officials in education institutes with reasonable concessions. Special screening test is being conducted to ensure health of the police personnel. Similarly MOUs have been signed with pathological labs for concession of fee for police officials.

Fare price shop/canteen has also been established in District Police Lines to provide the police personnel cheap commodities. This shop will be extended in the upcoming year.

It gives me great pleasure that the District Police Rajanpur will be able to achieve the targets in the current policing plan through dedication, devotion and commitment seeking guidance and active support from all segments of society including organizations working for the welfare of the public, please.
