It may be noted that Ministry of Religious Affairs & Interfaith Harmony reserves the right to reject any or all nominations or repatriate any selected member of Moavineen-e-Hujjaj in case his performance is found un-satisfactory or involves in any political activity during his / her stay at KSA forthwith, with the recommendation to initiate strict disciplinary action under the rules against the defaulter.

4. It is imperative to inculcate that members of Moavineen-e-Hujjaj are being sent to KSA on a sacred mission and now it is their duty to ensure a commensurate degree of service to the pilgrims.
