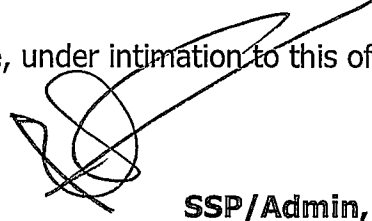

Section-I: Invitation to Bids

TENDER NOTICE

Electronic Bids (e-Bids) are invited for Procurement of Services for Laying, Installation & Commission of Optical Fiber Cable at CTD HQ, Opposite Jallo Park, Lahore (on Frame work contract basis) on e-Procurement System (e-Pak Acquisition Disposal System (EPADS) at website www.punjab.eprocure.gov.pk from Bidders i.e., firms/companies/sole proprietors/ general order Service Providers/ (JVs, if applicable) etc. engaged in trading, registered with relevant Registration Authorities and Tax Departments/ Authorities (Income Tax, Sales Tax & Punjab Sales Tax etc.) having valid professional tax certificate from Excise & Taxation Department and registered on e-Procurement System (EPADS), as detailed below:

Terms & CONDITIONS/ Instructions

1. All e-bids must be accompanied by a scanned Bid Security of the estimated price, as mentioned in the Table above, and in the form of CDR/Bank Guarantee / Demand Draft / Pay Order. Original Bid Security Instrument in an envelope clearly marked with the Bidding Document Number and Title must also be submitted before closing date & time. Late Bids/Bid Securities shall be rejected.
2. Technical and Financial Separate Bids, duly completed, signed, stamped, and in complete conformity with Tender/bidding Documents must be Submitted online on E-Pak Acquisition and Disposal System (EPADS) website i.e., <https://punjab.eprocure.gov.pk> as per following date and time:-

3. Bidders are advised to ensure uploading the Bids on EPADS Portal, well before the submission deadline, and not to wait for the last date and time to upload the bid. Bid submission on EPADS Portal shall entirely be the responsibility of the bidder. CTD will not be responsible for any issues

4. Bids that are incomplete, non-responsive, not signed and stamped, late, or submitted by other than a specified mode will not be considered for further process / evaluation.
5. For electronic bids submission, bidders are required to register at www.punjab.eprocure.gov.pk.
6. In case of public holiday on closing/opening date due to any reason, the date and time for submission of bid security and other required documents as well as opening the tenders will be considered the next working day. Counter Terrorism Department, Punjab will not be responsible for any cost or expense incurred by Bidders in connection with the preparation or delivery of Bid Security.

8. Any bidder may participate in complete package. All prospective bidders shall be required to quote rate of as per scope of services and financial bid form. The lowest evaluated bidder shall be determined on the cumulative quoted rate of complete services.
9. On acceptance of tenders, the bidders shall deposit performance guarantee **under PPRA Rules 2014, Section 56, Chapter VIII. @ 10%** of the total value of the contract in the form of bank guarantee in the name of the SSP/Admn, Counter Terrorism Department Punjab, Lahore and draw the contract agreements. Performance guarantee shall be refunded on successful completion of the contract.
10. (1) The SSP/Admn, Counter Terrorism Department Punjab, Lahore reserves the rights to reject all bids or proposals at any time prior to the acceptance of a bid or proposals **under Rules 35 of PPRA 2014.**
(2) The procuring agency shall, upon request, communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.
(3) Income/Sales tax registration certificate and other documents as mentioned in bidding document must accompany the Technical bids. Taxes will be deducted as per Government rules.

Note: All assessments and procuring procedure i.e. receiving, opening and awarding etc. shall be governed by the Punjab Procurement Rules-2014. In case of any conflict between Bidding Documents and PPRA Rules 2014, the rules shall prevail.
