- 2. Rates quoted would be considered only if the same are inclusive of all taxes/duties/charges and inclusive of packing/freight till delivery at the office of the SSP HQrs Farooq Abad District Sheikhupura and shall be valid up to **30-06-2019**
- 3. Supply shall be completed within 15 days from the date of order.
