DURATION

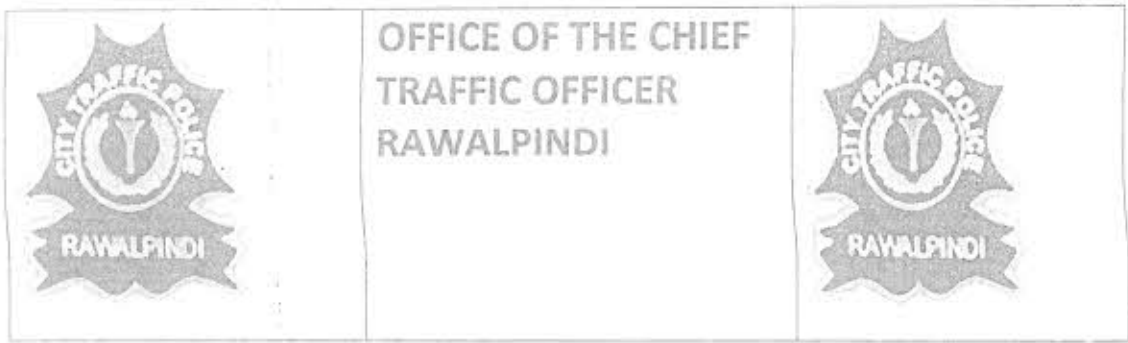
