1	Each bid shall comprise a single sealed package containing two separate envelopes as under:- 1). TECHNICAL PROPOSAL. (Details of stationary/printing Misc. items, Spare part of Vehicle & Mobil Oil on the firm's letter head pad along with bidding documents earnest money) 2). FINANCIAL PROPOSAL. (Rates of stationary/printing Misc. items, Spare part of Vehicle & Mobil Oil including all taxes / charges whatsoever, as per following form on the firm's letter head pad).

	The envelopes of bid & sample should be marked in bold letters as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL".														
2	Technical proposals will be opened on <u>28.11.2018 at 11:00 Hours</u> while financial proposals shall remain (in sealed form) in the custody of the undersigned and would be opened after receipt of the technical report, in the presence of qualified bidders. The technically qualified lowest bid would be accepted. The financial proposal of bids, if found technically un-acceptable shall be returned un-opened to the respective bidders.														
3	The bidders shall submit Earnest Money @ 3% of the total value of the contract with their financial proposals in the shape of Pay Order / Bank Draft of any														

	Scheduled Bank in favor of the SSP/CTD Faisalabad. In case of non-acceptance of tenders, the earnest money will be refunded after finalization of the tender.
4	In case of acceptance of tenders, the bidders shall deposit a security @ 5% of the total value of the contract in the form of deposit at call in the name of the SSP, CTD Faisalabad and draw the contract agreements. Security shall be refunded on successful completion of the contract.
5	The quantity of stationary/printing Misc. items, Spare part of Vehicle & Mobil Oil may be increased / decreased as per availability of funds.
6	The Departments reserves the right to accept or reject any or all tenders without assigning and reason.
7	The price of the items offered by the firm / bidders will be considered as net price (including all Taxes / duties / freight charges etc) and the firm / bidder will be bound to provide the tender items to the department on the approved / accepted rates till 30.06.2019 and afterwards.
8	The bidders are bound to provide their General Sales Tax number and will send the copy of General Sales Tax registration.
9	After the issuance of the supply order, the bidders / firms will be bound to deliver the items within 07 days. If the supplied items are not found according to the approved sample, the same will be rejected / returned on the expenses of the supplier and security / call deposit will be forfeited. Late delivery charges will be charged on the delay of the delivery according to the rules.
