

TENDER NOTICE

Sealed bids are invited from the manufactures, authorized and registered firms duly registered with Sales Tax Department on **22.08.2018** at 12.00 pm in DPO Office Mianwali under PPRA Rule, 2014 for the purchase/repair of furniture & fixture, purchase of stationery/computer stationery, toners printing/printed items, misc: store items, repair of building, missing facilities in police stations, repair of machinery, purchase of misc: items and maintenance of front desk in PSs, tent & pauls, uniform, sports items, expenditures/dietary items for Muharram/law & order duties, iron gates, barriers, iron grills for boundary wall, barbed/razor wires, tyres, batteries, spare parts, Mobil oil for vehicles, repairing of vehicles/boats, hot & cold, hiring charges etc: of Mianwali district for the fiscal year 2018-19. Tenders will be opened on **22.08.2018** at 12.30 pm in the presence of bidders. One sample of each item to be provided to check the quality and workmanship of the firm at the time of opening of technical bids. Authority letter of firm will be required to submit to show the participation of firm in the tender. Tender will be available at PPRA Website (<http://pprapunjab.govt.pk>): Bid Offer will be received in a phase alongwith two envelopes according to PPRA Rules, 2014. Bid Offer will consist on single page (two separate envelopes). Technical Proposal to be given in each envelop comparatively.

- 1) TECHNICAL PROPOSAL----(comprehensive detail of documents, specification of items, catalogue, permission letter, certification, sale tax, return on Income Tax certification should be given on the letter pad of the firm).
- 2) FINANCIAL PROPOSAL----- (In the letter pad of firm the price of every item alongwith tax charges and bider security 02 or 03 % should be available.

Technical and Financial Proposal alongwith item detail and firm name should be written on envelop.

3) TERMS AND CONDITIONS

1. The interested parties are required to submit their "**Technical Proposals**" and "**Financial Proposals**" in separate envelopes latest by **22.08.2018 at 12.00 PM** in the office of the DPO Mianwali. Technical Proposal will be opened by the Technical/Procurement Committee on **22.08.2018 at 12.30 PM** in the presence of bidders or their representative. All the proposals will remain with the department. Bidding will be opened in the presence of qualified bidder after receipt of Technical report. Lowest offer will be accepted on technical grounds. As per rule, accepted technical proposals will be returned to the bidder without opening.
2. All the bidder will have to deposit 02% of total Financial Proposal in shape of Bank Draft or Pay order in the name of DPO Mianwali. Without deposit security, the proposals will be rejected straightly. The security will be returned to the bidder in case of non-acceptance of offer at the end of the bidding.
3. According to PPRA Rules, 2014 procurement agency has the right to reject the bidding offer.
4. According to rules, the procurement agency can reject all the bids or proposals at any time prior to the acceptance of the bids proposals but the procurement agency shall upon request by any supplier or contractor who submitted a bid or proposal provide, the grounds of rejection of bids or proposals, but shall not require to justify those grounds.
5. All the interested parties can get bidding detail, speculations, offer term & condition from DPO Office Mianwali on their own letter pad till one day before the closing date by paying fee Rs.500/- (non-returnable).
