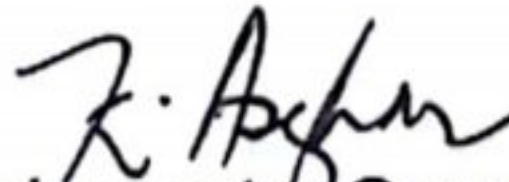

Bidding shall be conducted through Open Competitive Bidding (Single Stage-two Envelope) as per rule 38(2)(a) procedures specified in PPRA Rules 2014 (Amended upto 17.08.2020) and is open to all eligible bidders as defined in the bidding documents.

Tenders addressed to the Deputy Inspector General of Police, Investigation, Lahore, shall be received till **29.06.2024 till 11:00 am**, and shall be opened on the same day at 11:30 am in the presence of bidders in DIG/ Investigation Office, Lahore.

TERMS & CONDITIONS TO PARTICIPATE IN TENDER (FRAME WORK CONTRACT) FOR INVESTIGATION WING, LAHORE).

1. Each bid shall comprise two sealed package containing Technical & Financial Proposals envelopes as under:-

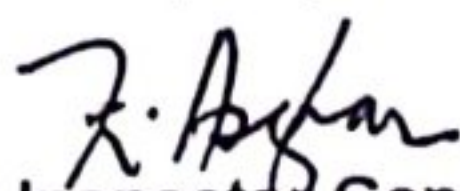
i.) **TECHNICAL PROPOSAL:** Detail of specifications, genuine, China, make country etc. On the firms letter head pad along with catalogue, bidding documents (Signed & Stamp), earnest money for respective item.

ii.) **FINANCIAL PROPSAL:** Rate of respective item including all taxes/changes whatsoever. as per following form on the Firms letter head pad:-

The envelope should be marked in bold letters "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" "Tender/Frame Work Contract for **Purchase of Office Stationery, Computer Stationery, Others Miscellaneous and Crime Scene Unit items, Printing & Publication, Repair of Machinery & Equipment, Repair of Furniture & Fixture, Tent & Tarpals including Repair, Sports Items, Hot & Cold, Purchase of Plant & Machinery, Purchase of Furniture & Fixture), Lubricants (Mobil Oil), ROT (Batteries, Tyres, Air Filters & Oil Filters) and Repair of Transport for financial year 2024-2025**" respectively with name of items.

1. The last date of tender submission is 29.06.2024 at 11.00 am and will be opened on the same date at 11.30 am.
2. Technical proposal will be opened at the time of opening of tender & Financial Proposal will be opened after finalization of Technical bid in the presence of bidders in the custody of the Committee and would be evaluated.
3. The bidders shall submit original earnest money @3% with their technical proposal of the estimated cost of in the shape of CDR/pay order/Bank draft of any Scheduled Bank in favor of the DIG/Investigation, Lahore. Earnest Money less than 3% of estimated cost of Tender/Frame Work Contract will lead to non-responsive and disqualification. In case of non-acceptance of tender earnest money will be refunded after Finalization of the tender. No copy of the same with Technical Proposal will be entertained at any cost and liable to be rejected.
4. In case of acceptance of tender, bidders shall deposit 5% performance security as per PPRA Rules and demand of department/authority, in the Form of deposit at call/CDR/pay order/Bank Draft/bank instrument in the name of DIG/Investigation, Lahore and draw the contract agreement. Security shall be refunded on successful completion of the contract or 30.06.2025 whichever is earlier.
5. Quantity of goods may be increased or decreased as to availability of funds.
6. Rates quoted would be considered inclusive of all taxes/duties/charges and valid up to 30.06.2025. Successful firm will provide required items as per place selected by the committee on his own transport.
7. The DIG/Investigation, Lahore, reserves the right to accept, reject all tender according PPRA rules.
