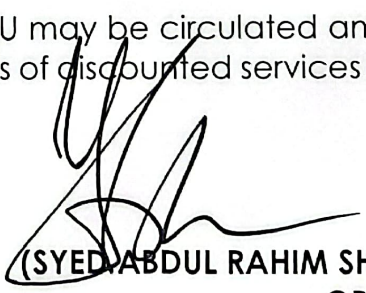
Subject **MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN PUNJAB POLICE

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) is made on November 04, 2025, between Police Department, Government of the Punjab, here in after referred to as the Punjab Police, which expression shall include its successors and assignees of One Part, and KIPS Education System all domains which include School, Colleges, Evening Coaching, Preparation, Keys Academy & 7Cs School, here in after referred to as the KIPS Education System, which expression shall include its representative and assignee of the Other Part, for special discounts in admission/tuition fee for the children of officers/ officials of Punjab Police (martyred, deceased, retired and serving), on terms and conditions, mentioned herein below: -

1. KIPS Education System shall provide fee discounts to the children of employees (Shuhada / Serving / Deceased / PSP Officers) of Punjab Police who are studying in all domains of KIPS Education System.
2. Student getting concession will have to abide by the prescribed criteria vis-à-vis other students.
3. A student desirous of availing special discounts in fee shall route his/her application alongwith requisite documents, to the Principal of KIPS Education System through the concerned Head of office of Punjab Police. Entries on KIPS ERP School Management System are mandatory.
4. Any direct application for concession in fee shall not be entertained by KIPS.

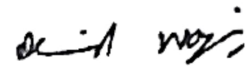
The details of concession for various categories are appended as:

1	Children of Shuhada	• Admission • Annual subscription • Monthly tuition fee • Security and admission processing	100%
2	Children of deceased employees of Punjab Police (those who have not attained the age of superannuation)	• Admission Fee • Monthly Tuition Fee.	40%
3	Children of Serving Officers / Officials	• Admission Fee • Monthly Tuition Fee.	35%

5. In addition to the above, any deserving student, being ward of Police employees will be given complete fee waiver on case-to-case basis.
6. In witness whereof, the parties through their duly authorized representatives, have executed this MOU on the days and dates set out below, and certify that they have read, understood and agreed to the terms and conditions as set forth herein.

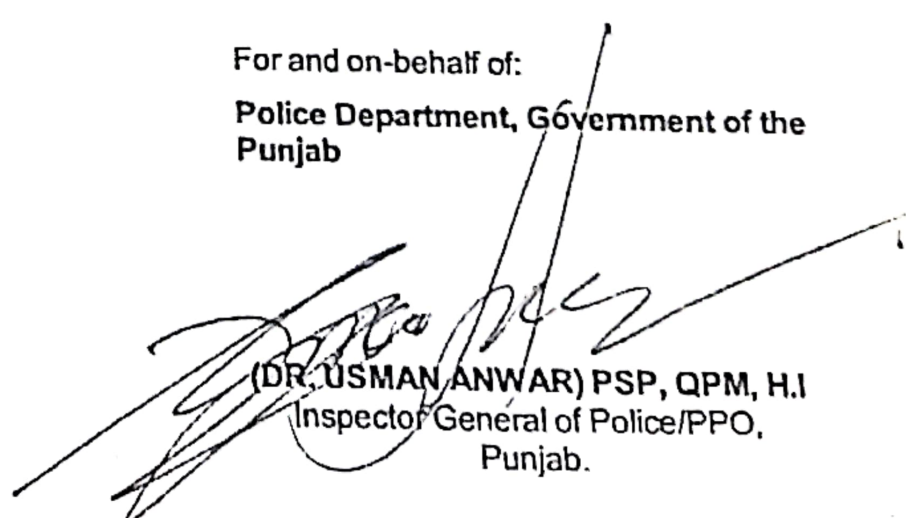
