Sr.#	Categories	Concession Limit
1	Children of Serving Employees	50% monthly Tuition/Admission Charges will have to be paid by the children of the In-Service Police Employees besides security (refundable) and monthly AC charges during the summer are applicable.
2	Children of Punjab Police Martyrs	Free-no fee (Tuition/Admission) will be charged from the children of Punjab Police Shuhada (Martyrs). Under this concession, students will have to pay security (refundable) and AC charges during the summer.

2. It is requested that the above said MoU may be circulated amongst all your respective subordinate staff for getting benefits of discounted services provided by the Unique Group of Institutions.

Memorandum of Understanding (MOU) Between Unique Group of Institutions & Punjab Police



The Memorandum of Understanding (MOU) signed on October 16, 2025 between Unique Group of Institutions (UGI) 106-A, New Muslim Town, Lahore through its Rector Prof. Amjad Ali Khan & the Punjab Police by DIG Operations Lahore Muhammad Faisal Kamran (PSP) for fee concession to the children of In-Service Punjab Police Officers.

The MOU to grant fee concession is an acknowledgement of the services rendered by the Punjab Police. It will apply to all Unique Schools, Colleges and Unique Science Academies in Punjab.

Sr. No	Categories	Concession Limit
1	Children of Serving Employee	50% monthly Tuition Fee/Admission Charges will have to be paid by the children of the In-Service Police employee besides security (refundable) and monthly AC Charges during the Summer.
2	Children of Punjab Police Martyr	Free – no fee (Tuition/Admission) will be charged from the children of Punjab Police Shuhada (Martyrs). Under this concession, students will have to pay security (re-fundable) and AC charges during the summer.

The fee concession is subject to fulfillment of the following criteria and conditions:

1. Only real children of the in-service Police Employee (sons/daughters) are eligible for the fee concession under this MOU.
2. A Candidate must bring a reference letter duly signed by RPO/DPO Office.
3. All other admission requirements will have to be fulfilled by the candidate including admission test as per UGI Policy.
4. The admission to a campus will be subject to availability of seat(s).
5. The focal person from Unique Group of Institutions will be Mr. Riaz Ul Haq (03214100439), while from Punjab Police Office, Hafiz Mubashir Iqbal (03214982881) I/C Welfare Branch DIG Operations Lahore will work as focal person from Punjab Police.
6. The MOU is Valid till March 31, 2027 and will be renewed with the mutual consent.
