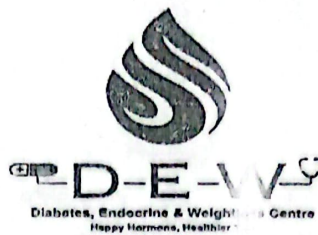

MEMORANDUM OF UNDERSTANDING (MoU)

Between
Dew-Prime Health Hub
(Located at 154-CCA, Phase 6, DHA, Lahore)
and
Punjab Police Department, Government of the Punjab

1. Purpose

This Memorandum of Understanding (MoU) is made and entered into on 31 October of, 2025, by and between **Dew-Prime Health Hub**, hereinafter referred to as "**DPHH**", and the **Punjab Police Department**, Government of the Punjab, hereinafter referred to as "**PPD**".

This MoU does not create any financial or legal obligation or partnership beyond the terms stated herein. Each party shall bear its own costs and expenses related to the implementation of this understanding.

7. Termination

Either party may terminate this MoU by providing **30 days'** written notice to the other party. Any obligations in progress at the time of termination shall be honored until completion.

8. Dispute Resolution

Any dispute or controversy arising out of or in connection with the MOU shall be resolved through mutual consultation and discussion between authorized representatives of both parties. The representatives' decision shall be final and binding upon both parties.
