2. In pursuance of above said letter of the NPB, MOI, Government of Pakistan, Islamabad, a provincial selection team under the chairmanship of Mr. Munir Masood Marth (PSP/BS-20), Dy. Commandant, Punjab Constabulary, Farooqabad has been constituted for conducting tests at provincial level.

3. CCPO Lahore, RPOs, and all heads of Police Units are requested to furnish nominations of only eligible candidates who meet the criteria given in the attached letter of NPB, directly to the chairman of the provincial selection team under intimation to this office.

4. Provincial tests will be held at the Punjab Constabulary Headquarters, Farooqabad. Arms/Ammunition for firing tests at provincial level will be provided by the Addl. IGP, Logistics & Procurement, CPO, Punjab from the CPO Arms/Ammunition Store, Farooqabad, on written requisition by chairman of the provincial selection team.

5. The timelines for nominations and screening, etc, are as under;

- a. Submission of nominations by CCPO/RPO/heads of units to Chairman provincial selection team upto 29.04.2019 on the following address under intimation to this office:  
"Mr. Munir Masood Marth (PSP/BS-20), Dy. Commandant, Punjab Constabulary, Farooqabad"
- b. Scrutiny of applications by the provincial selection team upto 02.05.2019.
- c. Provincial tests by the selection team from 03.05.2019 to 08.05.2019.
- d. Final merit list alongwith result will be furnished to Central Police Office, by chairman of the selection team on 09.05.2019.


6. The final merit list will be furnished by the chairman of the provincial selection team to this office on the following format:
