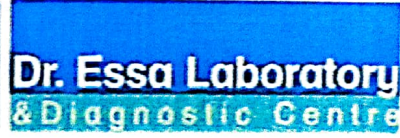

MEMORANDUM OF UNDERSTANDING (MoU)

Between

DR. ESSA Laboratory & Diagnostic Center Pvt. Ltd

and

Punjab Police Department, Government of the Punjab

1. Purpose

This Memorandum of Understanding (MoU) is made and entered into on 15 April of, 2026, by and between Dr. ESSA Laboratory & Diagnostic Center Pvt. Ltd, hereinafter referred to as "*ESSA Lab*", and the Punjab Police Department, Government of the Punjab, hereinafter referred to as "*PPD*".

Any dispute or controversy arising out of or in connection with this MOU shall be resolved through mutual consultation and discussion between authorized representatives of both parties. The representatives' decision shall be final and binding upon both parties.
