This Memorandum of Understanding (MOU) is made between:

PRESIDENT / VOLUNTEER SARWAR SHAHIDA RESEARCH INSTITUTE OF CARDIOVASCULAR SCIENCE TRUST. HEAD OFFICE: 36-KIYANI CHAMBER SESSION COURT GUJRANWALA.

And

THE POLICE DEPARTMENT, GOVERNMENT OF THE PUNJAB having its registered office at Central Police Office, 4-Church Road, Lahore (Here in after referred to as "The Punjab Police" Which, wherever the context so admits, shall include its successors and assignees) of the other part,

The Punjab Police and Sarwar Shahida Research Institute of Cardiovascular Science Trust may hereinafter be referred to individually as "party" and collectively as "the parties"

PRINCIPAL AGREEMENT

The parties do hereby agree:


1. That The Sarwar Shahida Research Institute of Cardiovascular Science Trust is ready and willing to provide following outdoor free Cardiovascular health facilities, to the families of Police Shuhada:
 - a. Cardiac risk assessment clinic.
 - b. Chest pain clinic.
 - c. Blood pressure & Diabetic clinic.
 - d. Heart failure clinic.
 - e. Heart Rhythm clinic.

That The Punjab Police is ready and willing to avail such services.


2. Now, therefore, in consideration of the premises and subject to the terms and conditions hereinafter set forth, the parties through this MOU do hereby mutually agree as follows:
 - The Sarwar Shahida Research Institute of Cardiovascular Science Trust will offer free of cost above said outdoor services at Doctor Shoaib Sawar Hashmi, Assistant Professor Cardiovascular medicine & Interventional Cardiology clinics in Gujranwala & Lahore with the mention contact # 0333-8143218 or 0331-1110922 for the referral and appointments.
 - The above said outdoor Cardiovascular Health facilities will only be provided to the Families of Shuhada of Police Department, duly referred by the District Head of Police, or having such card as this department may issue to the Shuhada families.
3. This agreement is for an initial period of one year, from the date of signing i.e. September 19, 2023. It may be extended / renewed with the mutual consent of the parties.
