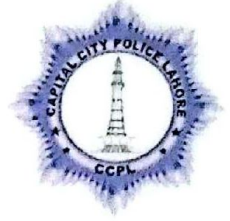


MEMORANDUM OF UNDERSTANDING



This Memorandum of Understanding (MoU) is made and entered into on this ____ day of _____, 2026, by and between the Mukhtaran Rafiq Welfare Hospital, an independent, non-political, and non-profit hospital located at Canal Bank Scheme, Fateh Garh, Lahore, duly registered with the Punjab Healthcare Commission, FBR, PCP, and Pakistan Charity Commission, hereinafter referred to as the "FIRST PARTY" (which expression shall be deemed to include its successors, assigns, and administrators) and Capital City Police Lahore, having its office at Lahore, hereinafter referred to as the "SECOND PARTY" (which expression shall, where the context so permits or requires, be deemed to include its successors-in-interest, administrators, substitutes, and permitted assigns),

Now, therefore, it is mutually agreed by and between the Parties as follows:

1. FIRST PARTY will provide **free OPD services to the employees** of Capital City Police Lahore and their blood-related dependent family members.
2. FIRST PARTY will **provide discounted surgeries** to the employees of Capital City Police Lahore and their blood-related dependent family members as follows:
 - 40% discount on General Surgeries
 - 50% discount on Gynecology Surgeries
 - 40% discount on Orthopedic Surgeries
 - 45% discount on Diagnostic Services (Lab & X-Ray)
3. FIRST PARTY will provide **blood pressure, diabetes, and cardiac screening facilities** to the employees of the SECOND PARTY and their blood-related dependent family members.
4. FIRST PARTY will provide **free medical checkup facilities** to their blood-related dependent family members of **Shuhada and Ghazis** of Capital City Police Lahore.
5. FIRST PARTY will provide **subsidized medicines to deserving patients** from the SECOND PARTY, subject to hospital policy.
6. FIRST PARTY will provide **dialysis support facilities** to eligible patients of the SECOND PARTY.
7. FIRST PARTY will provide **ALS/BLS Training Support** and awareness sessions for the staff of Capital City Police Lahore on need basis.
8. **Psychiatrist once in a week** will give the counselling session to the employees of the city traffic police employees, psychiatrist will be provided by the FIRST PARTY and space will be provided by the SECOND PARTY.

9. FIRST PARTY may organize quarterly **free medical camps and diagnostic** screening services for the employees of the SECOND PARTY whenever required.
10. The MoU shall come into effect on the date of signature by the Parties and shall remain effective for a period of one (1) year.
11. Either Party, upon thirty (30) days advance written notice to the other Party, may terminate this MoU at any time.
12. Any modification concerning this MoU may only be made by mutual written consent between both Parties.
13. In case of any disagreement arising with regard to the implementation or interpretation of this MoU, the Parties hereto may enter into joint consultations with the aim of reaching an amicable resolution of the same.

IN WITNESS WHEREOF, the above-said Parties have set forth their respective hands on the day and year Second hereinabove written.

IN WITNESS WHEREOF, the undersigned, being duly authorized representatives of the Parties, have executed this Memorandum of Understanding on the date written above.

Subject: **MOU BETWEEN MUKHTARAN RAFIQ WELFARE HOSPITAL & CAPITAL CITY POLICE LAHORE FOR PROVISION OF MEDICAL FACILITIES TO POLICE EMPLOYEES AND THEIR FAMILIES.**

Memorandum:

It is submitted that the Operations Wing, Lahore has signed a Memorandum of Understanding (MOU) with Mukhtaran Rafiq Welfare Hospital, Lahore, to provide medical facilities to the employees of Capital City Police Lahore and their blood-related dependent family members. The key details of the partnership are as under:-

- a) **OPD Services:** The hospital will provide free OPD services to the employees of Capital City Police Lahore and their blood-related dependent family members.
- b) **Discounted Surgeries:** The hospital will provide discounted surgeries as follows:
 - 40% discount on General Surgeries
 - 50% discount on Gynecology Surgeries
 - 40% discount on Orthopedic Surgeries
 - 45% discount on Diagnostic Services (Lab & X-Ray)
- c) **Screening Facilities:** The hospital will provide blood pressure, diabetes, and cardiac screening facilities to the employees and their blood-related dependent family members.
- d) **Shuhada & Ghazis:** The hospital will provide free medical checkup facilities to the blood-related dependent family members of Shuhada and Ghazis of Capital City Police Lahore.
- e) **Subsidized Medicines:** The hospital will provide subsidized medicines to deserving patients from Capital City Police Lahore, subject to hospital policy.
- f) **Dialysis Support:** The hospital will provide dialysis support facilities to eligible patients.
- g) **Training Support:** The hospital will provide ALS/BLS Training Support and awareness sessions for the staff of Capital City Police Lahore on a need basis.
- h) **Psychiatric Counseling:** A psychiatrist, provided by the hospital, will conduct weekly counseling sessions for employees of the City Traffic Police, with space provided by Capital City Police Lahore.
- i) **Medical Camps:** The hospital may organize quarterly free medical camps and diagnostic screening services for the employees whenever required.

Duration:

1. The MoU shall come into effect on the date of signature and shall remain effective for a period of one (1) year.

2. In view of the above it is requested that enclosed MOU be circulated to all RPOs, CPOs and DPOs across Punjab for the welfare of police personnel, please.

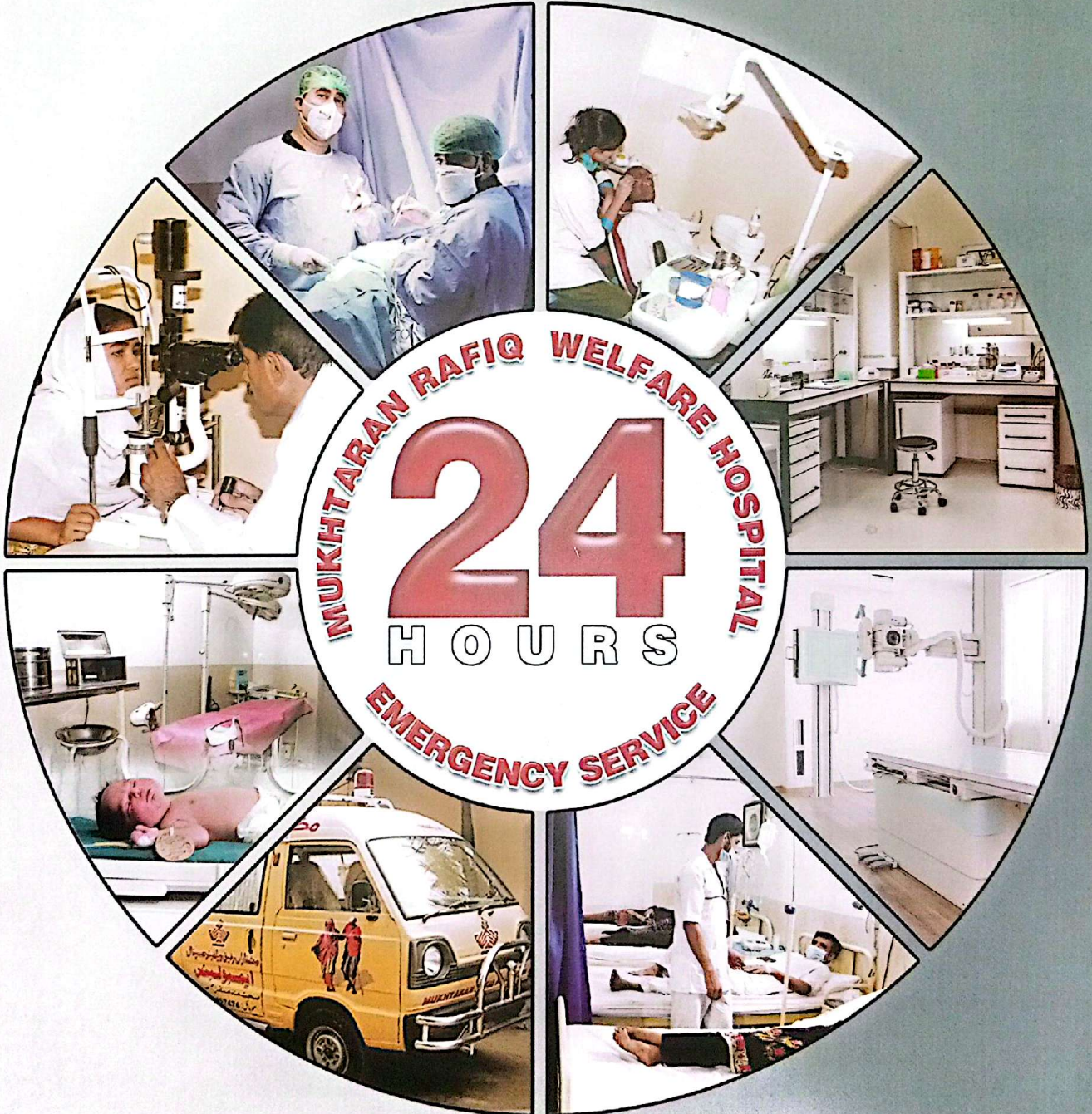
