The tenders be addressed to the Senior Superintendent of Police, Police Training School Farooqabad and would be opened on **01.05.2013** at PTS Farooqabad in the presence of bidders. The repairable articles should be examined in any working day during office hours till 30.04.2013. The offers shall be accepted only with original bidding documents. Photocopies shall not be accepted.

TERMS & CONDITIONS:-

1.	Each bid shall comprise a single sealed package containing two separate envelopes as under:- 1). TECHNICAL PROPOSAL (Detail of specification, make, country etc. on the firm's letter head pad alongwith catalogue, bidding documents, earnest money for respective items). 2). FINANCIAL PROPOSAL (Rate of respective item including all taxes/charges whatsoever as per following form on the firm's letter head pad): - The envelopes should be marked in bold letter as " Technical Proposal " and " Financial Proposal " respectively.
2.	Technical Proposals will be opened on 01.05.2013 while Financial proposals shall remain (in sealed form) in the custody of the PTS Farooqabad and would be opened in the presence of bidders. The technical qualified lowest bid would be accepted. The financial proposal of bids found technically un-acceptable shall be returned un-opened to the respective bidders.
3.	The bidders shall submit Earnest Money amounting to Rs: 50000/- with their technical proposals in the shape of Pay Orders/Bank Drafts of any Scheduled Bank in favour of the SSP PTS Farooqabad. In case of non-acceptance of tenders the earnest money will be refunded after finalization of the tender.
4.	The articles found not according to the standard specifications, will be rejected at the cost of the contractor and may also result in the forfeiture of security and black listing of the firm.
5.	Rate quoted would be considered only if the same are in Pak Rupees and inclusive of all taxes/duties/charges.
6.	Work will be completed within 15 days after issuance of work order.
7.	The undersigned reserves the right to accept or reject any or all tenders without assigning any reason.
