The participants would submit detail of experience for the maintenance of the system equipment along with dealership certificate (if any) as well as expert technical staff with their Technical Proposal. Technical proposals will be received in this office on **02.06.2020** till **11:00 am** and shall be opened on the same day **at 11.30 a.m.**, Financial Bid will be opened on the same day. The Technically qualified lowest bid, will be accepted.

The bidders shall submit Earnest Money @ **3%** of the estimated price, with their Technical proposal of the total value of their tender items in the shape of Pay Orders/Bank Drafts of any Scheduled Bank in favour of the AIG Logistics CPO, Lahore.
