

The Government of Pakistan, Ministry of Interior, Islamabad has informed that UN Police Division's Recruitment Officer and Selection Assessment and Assistance Team (SAAT) Coordinator has intimated that UNSAAT will be visiting Pakistan from 31<sup>st</sup> March, 2019 till 08<sup>th</sup> April, 2019. They will conduct test of already nominated/screened out Police officers at **Police Lines Headquarters, ICT Police Sector H-11 Islamabad from 01.04.2019 to 08.14.2019** (copy of which may be downloaded from the website of Punjab Police i.e. [www.punjabpolice.gov.pk](http://www.punjabpolice.gov.pk)).

3. The Police officers (as per enclosed list of 600 candidates) of your respective Regions/Units may be directed to report to the SSP (Headquarters), ICT Police, Islamabad **at 1100 hours on 31.03.2019** without fail, to appear in the said test.

4. All departments/units/regions/offices are requested to dispatch officers/officials (mentioned in the enclosed list) alongwith following (which will be checked several times):

- i Hard and soft copies of EASP (Electronic Application for Seconded Police) duly filled/typed and signed. (The candidates without EASP form or with hand written EASP form will not be accepted). EASP is available on Google.
- ii Service Photo ID Card (must be in English)
- iii CNIC (original)
- iv Passport (original), if available
- v Valid driving license (original)
- vi Hand Gun/Pistol with sufficient ammunition

5. Moreover, they must wear Police Uniform with the ranks to prove their identity to the Security Staff deputed at the venue of the test, otherwise entry would not be allowed under any circumstances.


